

## ENTRY REQUIREMENTS

### RULES

Booth space is 10' x 10'.  
Booth **MUST** be placed within designated space allotted.  
Vehicles are **NOT ALLOWED** to drive or park on the brick or cement walkways.  
Use of Plaza tables, benches, light poles or trees to assist in booth set-up is prohibited.  
Exhibitors are responsible for handling, erecting and removing display materials.  
No equipment or materials are provided.  
All exhibitors must have a 2A10BC portable fire-extinguisher located in the booth.  
If damage is determined by Fain Signature Group, the exhibitor will be responsible for the repair costs.  
Overnight security patrols are provided. Exhibitor is responsible for the security of his/her own property.  
Booth must remain open during show hours.  
Crafters are prohibited from distributing literature of, or promoting any religious, fraternal, political or commercial organization. Literature on the artist's/craftsperson's work or gallery is permitted.  
NO refunds for inclement weather or for noncompliance of show rules and regulations.  
Fain Signature Group reserves the right to remove any artist/craftsperson and their display for any violation of the rules and regulations of this show.  
Cleanliness of space during show and timely clean-up and removal of displays at end of the show is expected.

Arts and crafts are integrated – we accept a wide variety of fine art and unique individual crafts.

### PARKING

Exhibitor parking is **NOT ALLOWED** curbside around the Entertainment District except to load and unload.  
Exhibitors shall move their vehicles as soon as unloading and loading is completed.  
Set up can begin Friday at Noon, after check-in.

### SCREENING:

By jury/committee with photographs.  
Artists/Craftpersons will be notified acceptance or non-acceptance for the show.

Prescott Valley Main Street Faire Committee reserves the right to re-screen and perform on-site screening of artists/craftpersons at the discretion of the Committee. The Sponsors reserve the right to waive any and all requirements with regard to any entrant and such right may be exercised according to the Sponsor's unfettered discretion.

### 3-DAY ENTRY FEE:

**\$50** per space, **\$15** electric (if electricity is required by vendor)

Returned checks result in automatic cancellation. There are no exceptions.

### SHOW INFORMATION

Located in the Entertainment District at the heart of Downtown Prescott Valley, the show is surrounded by restaurants, sandwich shops, coffee houses, a 14-screen movie theater, retail and grocery stores – and provides ample parking for patrons and shoppers.

A number of events are planned to help drive traffic and add an atmosphere of fun to the sale area, including many family activities.

Booth spaces are on a wide cement/brick walkway. Vendor spaces will be assigned based on date of receipt and confirmation of application. Vendors may not request a specific space assignment unless the committee is made aware of unique special circumstances in advance. Vendors displaying similar items will be separated as space permits. Vendors requiring electricity will be assigned a space next to existing power sources. We hope to provide all Vendor spaces with three (3) open display sides. Vendor unloading is convenient at two (2) curbside locations.

Vendor set-up begins at Noon on Friday. In response to numerous requests from vendors, vendors who wish to arrive and set up Friday afternoon may sell Friday from set-up till 8 PM. Be aware that vendors will continue to arrive and setup during these hours. Vendors are not required to sell Friday. However, vendors **are required** to be set up and ready to sell Saturday 9am-5pm and Sunday 9am-4pm during show hours.

Overnight parking for self-contained RVs is available adjacent to the show location. Several motels are located within an easy walk or drive. A list of lodging convenient to the show site is available upon request.

A heavy advertising campaign has been scheduled for the 5<sup>th</sup> Annual Prescott Valley Main Street Faire. Ads in Newspaper(s), on radio and television; several banners, video board display on Highway 69; numerous radio and television talk show appearances (local, regional & state-wide); plus posters, handbills (1,000's) and more are all part of the promotion arsenal for this event!

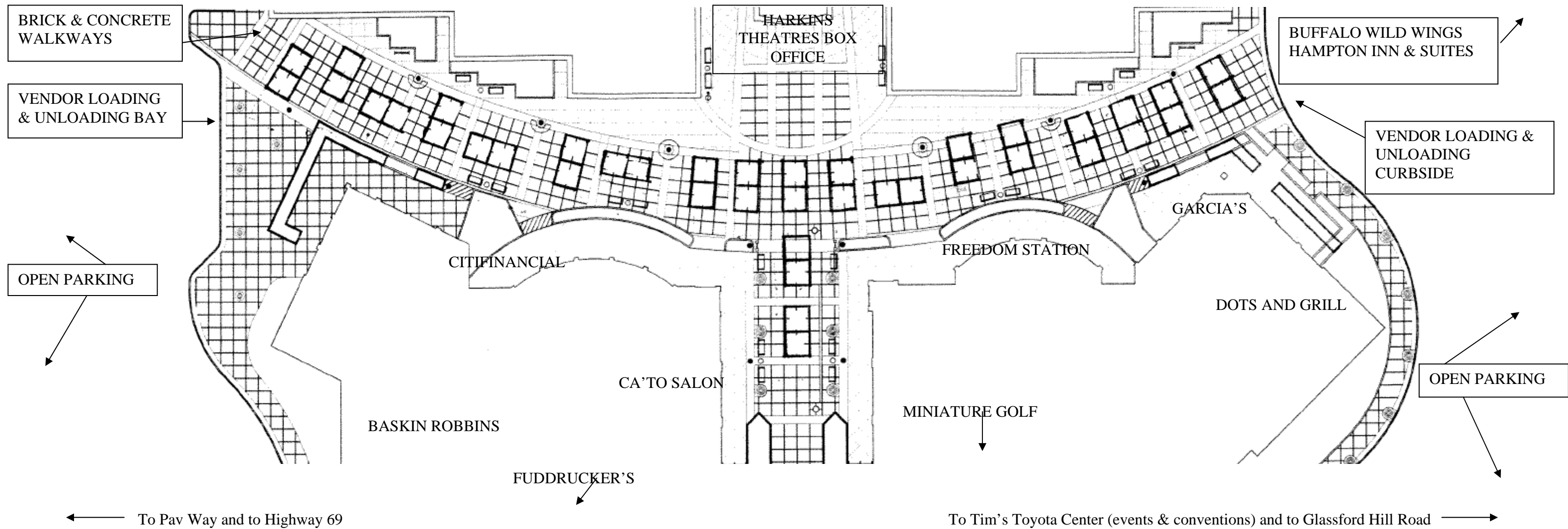

You must have a Vendor Parking Card displayed in your windshield to park in overnight Vendor Parking area. Overnight is allowed (no hookups).

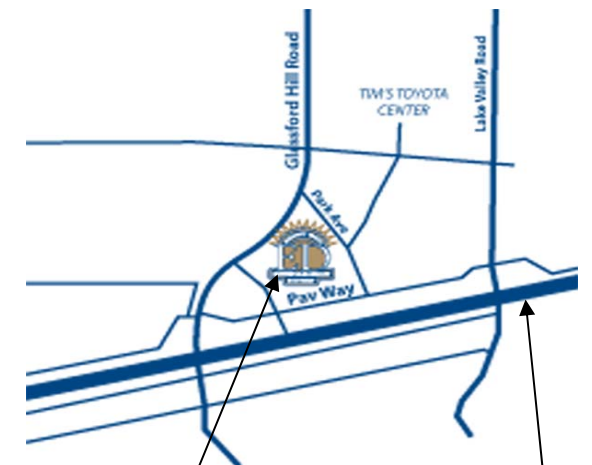
